- Must be registered with the Registrar of Companies and in good standing or Institution legally Registered;
- > Provide at least 3 reference letters stamped by the referring company;
- Must have been in practice for at least three (3) years;
- Provide certified copies of relevant certificates i.e. Certificate of Incorporation, VAT and BPN numbers; ZIMRA tax clearance certificate; NSSA clearance certificate and other relevant compliance certificates.

3. PROPOSAL REQUIREMENTS

3.3 Company Staffing

Name and CV(s) of the key staff who would be assigned to the development of this system.

3.4 Software System Development Implementation

Proposals must clearly show the company's understanding of the work to be performed, approach, and commitment to perform the work within a reasonable time period. (Include proposed timelines).

3.5 Fee Proposal

A breakdown of the proposed fees for the software and system development. Fees for any exceptional additional work not covered above and directly related to the development of this software system.
