### Urgent action needed to tackle stalled progress on health-related Sustainable

### **Development Goals**

WHO is releasing the 2023 edition of its annual World Health Statistics report with new figures on the impact of COVID-19 pandemic and the latest statistics on progress towards the health-related Sustainable Development Goals (SDGs). The report with data up to 2022 underscores a stagnation of health progress on key health indicators in recent years compared with trends seen during 2000-2015. It also alerts us to the growing threat of no communicable diseases (NCDs) and climate change, and calls for a coordinated and strengthened response. The report documents updated statistics on the toll of the pandemic on global health, contributing to the ongoing decline in progress towards the SDGs. During 2020-2021, COVID-19 resulted in a staggering 336.8 million years of life lost globally. an estimated \$3-6 trillion - and assesses how human activity and multiple global crises have significantly affected different sectors, including fishing, seafood, shipping and coastal tourism. ## African ministers of finance join forces to highlight the importance of financial sustainability in the response to HIV

Although great strides have been made in tackling HIV in recent years, Africa remains the continent most affected by HIV and progress towards ending AIDS is stalling. The COVID-19 pandemic, global inflation, growing debt levels, and a retreat from overseas development assistance by some donors are hampering Africa's efforts to ramp up national HIV responses and are jeopardizing broader outcomes for health, social development and economic growth. UNAIDS estimates that globally, low and middle-income countries will need investments of US\$ 29 billion annually to meet targets of ending AIDS as a public health threat by 2030. #### Zimbabwe to regulate carbon credit market to curb greenwashing

HARARE, May 23 (Reuters) - Zimbabwe's government will closely regulate voluntary carbon offset trading in a bid to curb greenwashing and ensure benefits for local communities, its environment minister has said. The global \$2 billion voluntary carbon offset market involves companies buying credits from emission reducing projects such as renewable energy or planting trees to offset their own emissions. Zimbabwe says organisations operating carbon credit projects in the country were largely unregulated as they were only registered with local councils and traditional community leaders -- a result of which there is no reliable data on the size of Zimbabwe's carbon market. ### Zimbabwe starts developing its 2.0 One Health AMR National Action Plan

Bulawayo, Zimbabwe - The Government of Zimbabwe has commenced updating its antimicrobial resistance (AMR) National Action Plan (NAP) 2023-2027, to replace the previous NAP (2017-2021) which had lapsed. The process is being led by the Ministry of Health and Child Care (MoHCC), Ministry of Lands, Agriculture, Fisheries, Water, Climate and Rural Development and the Ministry of Environment with support from the Food and Agriculture Organization of the United Nations (FAO) and the World Health Organization (WHO). The review provides an opportunity to assess the impact of activities carried out during the last five years and assist with developing evidence-based policies and decisions and evaluate procedures and indicators that could be adopted achieve strategic objectives new plan.
